Floor Plan

We will discuss your needs for a floor plan and table setting arrangements prior to the event and this will be finalised when your final numbers are confirmed 48 hours prior to the reception.

Photographs & Confetti

Feel free to use our lawns for your wedding photographs, during the day or at sunset. There is not a more picturesque background in Darwin! Please advise your guests that we request that **no confetti or rice** is thrown on the grounds of the complex. An alternative to confetti is flower petals or bubbles.

Last Drinks

All good things must come to an end! Our bar closes at 12.00 midnight sharp.

Music

Please discuss music options with Lily or Brigitte as noise restrictions do apply to functions who do not take out sole use of the venue. All music is to finish at 12:00 midnight sharp.

Reservations & Deposits

To confirm your reservation a minimum deposit of \$1000.00 will be required *within fourteen days* of the initial booking. A surcharge for functions held on Sundays or public holidays may apply and this will be negotiated at the time of the booking. If a deposit is not received within the specified time period, the initial reservation cannot be guaranteed.

Terms & Conditions of Deposit - Deposits are strictly non-refundable.

Guest Numbers

To book a Friday night function at Pee Wee's a minimum spend of \$6000.00 (incl GST) is required on food and beverages. Please note this is not the price for sole use, only exclusive use of the lawn area.

To book a Saturday night function at Pee Wee's a minimum spend of \$8000.00 (incl GST) is required on food and beverages. Please note this is not the price for sole use, only exclusive use of the lawn area.

To book a Sunday night function at Pee Wee's a minimum spend of \$5000.00 (incl GST) is required on food and beverages. Please note this is not the price for sole use, only exclusive use of the lawn area.

Sole use of the entire venue for the night requires a minimum spend of \$13 200.00 (incl GST) on food and beverages.

All minimum spend requirements are negotiable in the off peak season, please speak with either Lily or Sandy.

Holding Your Function On Lawn Area

We are happy to arrange your function on our seafront lawns from May to October - and what a magnificent spot it is! The lawn area can accommodate up to 250 people (seated) and 350 (standing). A hire fee of \$500.00 is required to use the lawn area.

Full Payment

Full payment of total costs is required 48 hours prior to the completion of the function, unless prior arrangement for invoicing has been made. Every possible effort is taken to maintain prices, but these are subject to change to allow for market cost variations. The prices shown are inclusive of GST. Payment can be made by cash, credit card or direct debit into our bank account. Pee Wee's also require credit card detail to be given as a security bond for any Bar Tabs or damages on the night.

Additional Costs

White linen tablecloths cost an additional \$2.50 per person. If you would like your wedding cake served or plated in addition to the desserts specified, this incurs an additional cost of \$5.00 per head.

Wedding Ceremonies

If you hold your reception at Pee Wee's it is possible to have your wedding ceremony on our beautiful lawn area by prior arrangement only and if the space is available. The area will be set with chairs for your guests and a table for signing documents. A cost of \$500.00 will be charged to cover the cost of this set up.

Cocktails & Canapés

You may like to consider offering your guests pre-dinner drinks and canapés at sunset. Our canapé menus and prices are enclosed.

Sole Use Of Site & Responsibility

As you are aware, Pee Wee's is a very large area. Please be aware that unless you request and pay for sole use of the site you may not have exclusive use of the complex. We will ensure that you have plenty of space and an area will be designated for your private use. Although all care is taken, Pee Wee's at the Point shall not be responsible for loss of or damage to, property left on the premises prior to, during or after an event. The client accepts financial responsibility for any damage to the venue, it's fittings or equipment caused by the clients guests or by outside contractors engaged by the client prior to, during, or after the event.

- We can tentatively hold a reservation for up to fourteen days before a deposit of \$500.00 is required.
- At the time of confirmation a signed copy of these conditions is also required.

Your reservation is accepted on the following conditions:

- Final numbers of guests attending the function is required by 2pm two full working days prior to the event. Charges will be based on those numbers unless final numbers are greater than those confirmed prior to the function.
- Please advise your menu selection at least 14 working days prior to the event.
- The standard completion time for all functions is 12:00 midnight. The bar will close and all music must end at midnight. Guests then have half an hour to leave the complex. A surcharge for functions held on Sundays or Public Holidays may apply and this will be negotiated at the time of booking.
- Full payment for the function will be required at conclusion of the function by cash, credit card or company cheque. Payment by cheque or EFT is by prior arrangement only. Credit will only be given by prior arrangement, in order for credit facilities to be set up.
- Every possible effort is taken to maintain prices, but these are subject to change at the Management's discretion to allow for market cost variations and the introduction of any new statutory taxes.
- The function organiser is financially liable for any damages sustained to the complex property, fixtures or fittings whether through their own actions or the actions of their guests, contractors or subcontractors. The organiser and their guests will conduct their function in an orderly manner. Pee Wee's at the Point reserves the right to eject any objectionable persons from the function without liability. It is law that intoxicated persons must not be served alcohol, if an intoxicated person is denied service they must leave the restaurant and the grounds of the complex immediately.
- Pee Wee's at the Point will take all possible care, but accepts no responsibility for any loss or damage to merchandise or other property of the organiser in the complex prior to, during, or after functions. We recommend that organisers take out their own insurance cover.
- Performance of this agreement is contingent upon the ability of the complex to complete the same, and is subject to labour troubles, accidents, government requisitions, restrictions on food, beverages or supplies; and other causes, whether stated herein or not, which are beyond the control of the complex. In no event shall the complex be liable for the loss of profit or of other similar for any function.
